## SECTION 3 : HAZARDS IDENTIFICATION

Eyes contact : Direct contact may cause irritation, redness and pain.  
 Skin contact : May cause skin irritation. May be absorbed through the skin with possible systemic effects.  
 Inhalation : May cause dizziness and euphoria leading to unconsciousness in severe cases. Vapors also irritate the respiratory tract. Symptoms may include coughing, difficult breathing and chest pain.

### Effects of repeated overexposure

#### SECTION 4 : FIRST-AID MEASURES
